



September 12, 2022 Monthly Meeting Minutes

1. Discussion/input into future meeting agenda topics. Thanks to our volunteers!
 - a. October: Funding initiatives Mark Strudley, Natalie Muradian, Mith Avalon: ART Flood Explorer
 - b. November: Santa Cruz on the Pajaro River Vegetation Management Project, Rusty Barker

 - d. January: NAFSMA expert to speak about Boise vs Martin (Mark Strudley to arrange)
2. Discussion of possible BAFPA IRWMP Projects. The group discussed hiring a consultant to work for BAFPA members in developing climate updated models for flood model inputs. After discussion, the group decided not to develop an application together. The group also discussed looking at the success of natural recruitment in mitigation (versus planting and watering). Not moving forward with this idea either.
3. Tess Byler shared the San Franciscquito JPA Climate Change Impact Assessment Reach 2 (Urban Reach) Project (attached to minutes).
4. MOU Revision: Elke still working on this.
5. FMA debrief: Carlos went for the first time in 5 years. Theme - fostering innovation. Carlos was on panel on Flood MAR. Discussion on pulling Flood agencies and GSAs into flood aquifers. Big Central Valley focus. Paul Detjens presented on lower Walnut Creek. Roger Leventhal presented on Army Corps/Sea Level Rise in the Bay Area.
6. Homelessness Committee: Carol is not sure how to proceed with this topic. Mark Strudley noted that NAFSMA is putting on committee meetings on Homelessness on 10/6. Mark will invite a NAFSMA expert to speak about Boise vs Martin at a future meeting.
7. Carol: [Estuary Blueprint](#) has been released. Includes the delta. Also see Knee Deep Times re climate change. A link to sign up for [Knee Deep Times](#).
8. Carol is tracking flood legislation. Pajaro River Bill 489 might get signed. Mark - this allows the state to subvent funds. Carol - this bodes well for others in the Bay Area to get state funds. Mark will also work on presenting on this topic too, for early next year.
9. AQPI
 - a. Santa Cruz installed their radar last month. Was covered in the [Sunday Sentinal](#). Not running because a computing piece didn't arrive. Calibrating this winter. May make public this spring. Would like to include AQPI in One Rain display.
 - b. Rocky Ridge to be installed later this fall. SW has a new contractor to install the radar. CCC has a communications blip that it needs to work on.
 - c. Zone 7 has another vendor, not One Rain. [AQPI link](#).
